The mission of **EDQ** is to promote research supporting the formulation of evidence-based economic development and workforce development policy, programs, and practice in the United States.

EDQ takes a *multidisciplinary approach* in promoting applied research that explores the wide range of economic and workforce development issues and policies including (but not restricted to):

- Economic Development Policy, Practice, and Strategy
- Workforce Development Policy, Practice, and Strategy
- Economic Development and Workforce Incentives
- Regional Innovation and Technology
- Small Business/Entrepreneurship
- Business Location Theory
- Spatial Economics: Industry Clusters/Agglomeration
- Social Networks
- Community Development
- Economic Development Financing
- Urban and Rural Development
- Government Structure and Economic Development

EDQ is a double-blind, peer-reviewed journal and requires no fees for submissions. Articles are reviewed by no fewer than three reviewers. EDQ accepts the following types of submissions:

1. Original Articles between 6,000 and 8,000 words; word count does not include figures and tables (peer reviewed)
2. Research Notes (shorter articles) between 5,000 and 7,000 words; word count does not include figures and tables (peer reviewed)

The W.E. Upjohn Institute for Employment Research is a private, nonprofit, nonpartisan, independent research organization devoted to investigating the causes and effects of unemployment (www.upjohn.org). The Institute houses EDQ, which is published by Sage Publications, and both are committed to advancing applied research on economic development and workforce development that can inform policy.

3. Commentaries (opinion articles) between 3,000 and 8,000 words (reviewed by Timothy Bartik, Co-Editor)
4. Literature Review Essays between 6,000 and 8,000 words; word count does not include figures and tables (peer reviewed)
5. Book Reviews (reviewed by Neil Reid, Book Review Editor)

Our review process strives for timeliness. All submitted manuscripts are immediately reviewed by the editorial staff, which often includes an Associate Editor, to determine if the manuscript is appropriate for the journal and merits peer review. Manuscripts deemed appropriate are submitted to peer reviewers within 21 days of submission. Our goal is to provide authors with a decision (acceptance, conditional acceptance, revise and resubmit, or rejection) within 101 days of submission. Of course, requests to resubmit revised manuscripts will lengthen the process to publication.
